**JOURNAL ENTRY AND ORDER APPROVING MOTION FOR
AUTHORITY TO DESTROY CERTAIN RECORDS
OF THE CREDIT GENERAL LIQUIDATION ESTATE**

This matter came before the Court upon the motion ("Motion") of Mary Jo Hudson, Ohio Superintendent of Insurance, in her capacity as the Liquidator of Credit General Insurance Company and Credit General Indemnity Company (collectively "Credit General"), for authority to destroy 1060 boxes of pre-liquidation boxes of Credit General at 3691 Interchange Road in Columbus, Ohio relating to matters no longer useful to administer the Credit General liquidation estates. No party objected to the Motion. Upon consideration of the Liquidator's Motion and Memorandum in Support, the Court finds the Motion is well taken and it is hereby:

ORDERED, ADJUDGED AND DECREED that the Motion is granted in its entirety.

IT IS FURTHER ORDERED that the Liquidator is hereby authorized and directed to destroy the 1060 boxes of Credit General records at 3691 Interchange Road in Columbus, Ohio relating to matters that are no longer useful or required to administer the

Credit General liquidation estate as determined by the Liquidator and to pay the approximately \$6,000 to do so.
