As set forth in this Court's Order of August 5, 2008, Plaintiff, Mary Jo Hudson in her capacity of Rehabilitator ("Rehabilitator") of Defendant Guarantee Title and Trust Company (In Rehabilitation) ("Guarantee") presents the following agenda for the hearing scheduled at 9:00 a.m. on Monday August 18, 2008:

1. If necessary because of any filing made in accordance with this Court's August 5, 2008 Order concerning the August 18, 2008 Hearing, any and all matters presented to this Court in the Rehabilitator's Motion for Clarifying Order and this Court's August 5, 2008 Order reiterating the status quo for the 90 day period while the Rehabilitator determines the financial condition of Guarantee.

2. If necessary because of any resistance of Christopher M. Likens, who controlled through ownership of holding companies Guarantee and numerous Nations Title Agencies, any

other person involved with or related to any aspect of Guarantee's affairs, and/or any Nations Title Agency as provided in the attached Schedule 1, to provide documents and/or files as requested by the Rehabilitator, an Order directing all Nations Title Agencies to provide any and all documents and/or files in any way related to, pertaining to or concerning Guarantee in any manner, including but not limited to any transaction, any claim by or against Guarantee or any underwriting file. See July 28, 2008 Agreed Order Appointing Rehabilitator paragraphs 4 and 12.


3. The Rehabilitator's engagement of Richard J. Lolli to appraise the value of two title agencies operated by Guarantee doing business as Title Quest in Reynoldsburg, Ohio and Pace, Florida and as needed, to provide expertise in the general fields of title insurance and title insurance agencies. Mr. Lolli founded and served as President of Colonial Title Agency, Inc. in Canton Ohio from 1985 to 2000 before selling it and has been since 2001 and is currently President of Certified Title Agency, Inc. Additionally, Mr. Lolli is a partner in the law firm of Buckingham, Doolittle and Burroughs in Canton, Ohio. Upon the Court's request, the Rehabilitator will submit Mr. Lolli's CV and billing rates.

4. Any additional items that may arise prior to the August 18, 2008 hearing which require this Court's attention.


