- Overview of Closed Liquidation Proceeding

The Guarantee Title and Trust Company ("GTT"), a title underwriter domiciled in Ohio, was ordered into court-supervised liquidation proceedings on October 27, 2008, by the Franklin County Court of Common Pleas. # See GTT Liquidation Order under **Public Documents**, dated [10/27/2008](#). #The liquidation of GTT followed efforts to rehabilitate the company and to find a buyer for GTT's business, both of which failed. # Due to GTT's liquidation, the cancellation of all of GTT's title policies and the claims filing deadline and absolute final bar date for claims in the GTT liquidation proceeding, it is no longer possible to file a title claim against GTT.

Policy Cancellation November 26, 2008

The GTT Liquidation Order cancelled all policies of insurance issued by GTT **effective no later than 12:01 a.m., November 26, 2008**. The Liquidation Order also provided that the Liquidator disavowed all mutual indemnity agreements, indemnity letters and any other similar contracts or obligations of GTT effective October 27, 2008. # See Notice of Liquidation under **Public Documents**, dated [10/27/2008](#). Claim Filing Deadline and Absolute Final Bar Date October 27, 2009

On October 27, 2008, the Court established a claim filing deadline and absolute final bar date for all claims against GTT. See Notice of Liquidation under **Public Documents**, dated [10/27/2008](#).

GTT Liquidation Proceeding Closed

On September 27, 2011, the Court entered a **Final Closing Order** that Granted the Liquidator's Application for Order Authorizing Final Distribution, and Terminating the Liquidation Proceedings of GTT, and Ordered the GTT liquidation closed and the liquidation case terminated. # See Final Closing Order under **Public Documents**, dated [9/27/2011](#).

GTT Company Records Destroyed

Pursuant to Court Orders, the pre-liquidation and post-liquidation records of GTT have been destroyed.
