This matter came to be heard upon the Motion of the Liquidator of the American Druggists' Insurance Company ("ADIC"), to approve the Liquidator's Report of Claims, Distribution to Class 1 and Class 2 claimants and related actions of ADIC. Upon consideration of the Liquidator's Motion, Memorandum in Support and Exhibit, the Court finds the Motion is well taken and it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. It is hereby ORDERED that the Liquidator's Report of Class 1 and 2 Claims and the values of the claims as set forth therein, attached hereto as Exhibit A, is hereby approved;

2. It is further ORDERED that the distribution of ADIC assets in the amount of Fourteen Million Seven Hundred Forty-Seven Thousand One Hundred Ninety-Five Dollars and Ninety-Three Cents (\$14,747,195.93) payable in accordance with this Report of Claims is hereby authorized, with the exception of the William Kapp claim, as listed thereon, which shall be distributed as directed and upon the further Order of this Court specific to the Kapp claim; and,
3. It is further ORDERED that any contingent or future Class 1 or Class 2 claim(s) and any Class 1 and Class 2 claim(s) not included in this Report of Claims and not previously disallowed or zero valued are hereby foreclosed and disallowed, with the exception of the claim of the New York Liquidation Bureau which has yet to be finally determined and is not participating in this distribution, all as more fully described in the attached Memorandum in Support.
