**JOURNAL ENTRY APPROVING THE LIQUIDATOR'S REPORTS  
OF CLAIMS OF CLASSES 6, 7, 8 AND 9, DISTRIBUTIONS TO CLASS 6,  
CLASS 8 AND CLASS 9 CLAIMANTS AND RELATED ACTIONS OF  
AMERICAN DRUGGISTS' INSURANCE COMPANY**

This matter came to be heard upon the Motion of the Liquidator of the American Druggists' Insurance Company ("ADIC"), to approve the Liquidator's Reports of Claims for Classes 6, 7, 8 and 9 claims, and related distribution to Class 6, Class 8 and Class 9 claimants of ADIC. Upon consideration of the Liquidator's Motion, Memorandum in Support and Exhibits, the Court finds the Motion is well taken and it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. It is hereby ORDERED that the Liquidator's Reports of Class 6 , Class 7, Class 8 and Class 9 Claims, with all of Class 7 Claims being zero valued, including the determination of the amounts and the class of each claim as set forth therein, which are attached hereto as Exhibit A, B, C and D respectively, are hereby approved;

2. It is further ORDERED that the distribution of ADIC assets in the total amount of Six Million, Five Hundred Four Thousand, Three Hundred Fifty-Three Dollars and Six Cents (\$6,504,353.06), payable in accordance with the Liquidator's Reports of Class 6, Class 8 and Class 9 Claims, is hereby approved and authorized; and,
3. It is further ORDERED that any contingent or future Class 6, Class 7, Class 8 and Class 9 Claims, and any Class 6, Class 7, Class 8 and Class 9 Claims not included in the Liquidator's Reports of Claims and not previously disallowed or zero valued, are hereby foreclosed and disallowed.


