**NOTICE OF COLONIAL INSURANCE COMPANY'S SALE OF ITS MEDICARE  
SUPPLEMENT INSURANCE LINE PURSUANT TO ITS COURT-APPROVED  
REHABILITATION PLAN**

Pursuant to Colonial Insurance Company's ("Colonial") court-approved rehabilitation plan ("Plan"), Plaintiff Ann H. Womer Benjamin, Superintendent, Ohio Department of Insurance, in her capacity as Rehabilitator of Colonial, presents Notice to the Court that Colonial has sold its block of Medicare Supplement ("MS") insurance. According to this Court's April 5, 2004 Order Approving Rehabilitation Plan for Colonial Insurance Company, the Rehabilitator was to sell Colonial's block of MS insurance to an alternate insurer in order to ensure the continuation of coverage for Colonial's MS policyholders. On or about October 31, 2004, Colonial entered into an Assumption Reinsurance Agreement ("Agreement") with Bankers Fidelity Life Insurance Company for the sale of Colonial's block of MS insurance. The Agreement is attached to this Notice as Exhibit A.
