**ORDER GRANTING LIQUIDATOR'S MOTION FOR AUTHORITY TO DESTROY  
CERTAIN RECORDS OF CREDIT GENERAL INDEMNITY COMPANY AT  
FIREPROOF RECORDS CENTER**

This matter is before the Court upon the motion of Mary Taylor, Ohio Superintendent of Insurance, in her capacity as Liquidator (the "Liquidator") of Credit General Indemnity Company ("Indemnity"), for an Order authorizing the Liquidator to destroy certain records of Indemnity that the Liquidator identified in the Memorandum in Support and the Exhibits attached to the motion (the "Motion"). Upon consideration of the Liquidator's Motion, Memorandum in Support and Exhibits, the Court finds the Motion is well taken and is hereby GRANTED. It is further ORDERED, ADJUDGED AND DECREED that:

1. The records identified in the Motion, Memorandum in Support and Exhibits are no longer useful to administering the Indemnity liquidation estate.
2. In order to conserve estate assets for the benefit of policyholders and claimants, the Liquidator is authorized and directed pursuant to R.C. § 3903.48 to immediately destroy the records identified in the Memorandum in Support and Exhibits attached to

the Motion, specifically records stored at Fireproof Records Center in Grove City, Ohio.

3. This is a final, appealable order and there is no just cause for delay.


