**ORDER GRANTING LIQUIDATOR’S MOTION AND APPLICATION FOR ORDER (1) APPROVING LIQUIDATOR’S FINAL REPORT OF CLAIMS, FINAL RESERVE AND PAYMENT OF ADMINISTRATIVE EXPENSES, AND AUTHORIZING FINAL DISTRIBUTION OF THE ASSETS OF CREDIT GENERAL INDEMNITY COMPANY; AND (2) REQUIRING THE FILING OF THE UNREDACTED REPORTS OF CLAIMS UNDER SEAL**

This matter came to be heard upon the Liquidator’s above-captioned Motion and Application filed pursuant to R.C. §§ 3903.42, 3903.43, and 3903.44 and related sections. Upon consideration of the Liquidator’s Motion and Application, Memorandum in Support, Exhibits, including the Liquidator’s Final Report of Class 1, Class 2, and Classes 3 through 9 Claims, the Court finds that good grounds exists for the Motion and that the Motion is well-taken, and, it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. The Liquidator’s Motion is GRANTED in its entirety.
2. The Liquidator’s Final Report of Claims in Class 1, Class 2, and Classes 3 through 9 attached as Exhibits A, B and C to the Motion, including the

determinations of the amounts, if any, and classes of each claim as set forth therein, is hereby approved.

3. The Liquidator's reservation of the amount of \$44,287.31, as detailed in Exhibit D attached to the Liquidator's Motion, from the assets of the Indemnity estate for the Liquidator's payment of administrative expenses under Class 1 of R.C. § 3903.42 related to closing the Indemnity estate, that the Liquidator incurred, but has not yet paid, or anticipates will necessarily be incurred in this regard on or after October 7, 2013, is hereby approved and authorized pursuant to R.C. § 3903.42.
4. The Liquidator is hereby authorized to make a 100% final distribution of Indemnity's remaining assets to claimants in Class 1 in the amounts set forth in Exhibit A, and to make a final pro-rata distribution of Indemnity's remaining assets to claimants in Class 2 in the amounts as detailed in Exhibit B, and finding that this final distribution of Indemnity's assets is conclusive with respect to all claimants, whether or not they received notice, pursuant to R.C. § 3903.22(C).
5. Due to the confidential nature of the claimant information contained in Exhibits B and C to the Motion, the Liquidator's *Motion for Order Approving Liquidator's Filing of the Unredacted Reports of Claims Under Seal* is hereby GRANTED and that unredacted Exhibits B and C to the Motion shall be filed with the Franklin County Clerk of Court UNDER SEAL.

It is so ORDERED.


