ORDER GRANTING LIQUIDATOR'S AMENDED MOTION AND APPLICATION FOR ORDER APPROVING (1) LIQUIDATOR'S FINAL REPORT OF CLASS 1, 3 AND 5 CLAIMS AND CORRECTED FINAL REPORT OF CLASS 2 CLAIMS, RESERVE AND PAYMENT OF ADMINISTRATIVE EXPENSES AND AUTHORIZING FINAL DISTRIBUTION OF THE ASSETS OF ACCELERATION NATIONAL INSURANCE COMPANY; AND (2) FILING OF THE UNREDACTED REPORTS OF CLAIMS UNDER SEAL

This matter came to be heard upon the Liquidator's above-captioned Amended Motion and Application filed pursuant to R.C. 3903.42, 3903.43, and 3903.44 and related sections. Upon consideration of the Liquidator's Amended Motion and Application, Memorandum in Support, Exhibits, including the Liquidator's Final Report of Class 1, Class 3 and Class 5 Claims, and corrected Final Report of Class 2 Claims, the Court finds that good grounds exist for the Motion and that the Motion is well-taken, and, it is hereby ORDERED, ADJUDGED and DECREED as follows:

1. The Liquidator's Amended Motion is GRANTED in its entirety.
2. The Liquidator's Final Report of Claims in Classes 1, 2 (corrected), 3 and 5 attached as Exhibit A to the Motion, including the determinations of the amounts and the classes of each claim as set forth therein and in Exhibit B, is hereby approved.
3. The Liquidator's reservation of the amount of \$54,009.12, as detailed in Exhibit C attached to the Liquidator's Motion for the reserve and prepayment of administrative expenses under Class 1 of R.C. 3903.42 related to closing the Acceleration National Insurance Company ("ANIC") estate, that the Liquidator incurred, but has not yet paid, or anticipates will necessarily be incurred in this

regard after August 18, 2012, is hereby approved and authorized pursuant to R.C. 3903.42 and R.C. 3903.46(A).

4. The Liquidator is hereby authorized to make a final pro rata distribution of the remaining assets of ANIC (after subtracting the \$54,009.12 reserve for administrative expenses) as detailed in Exhibits A and B. This final distribution of ANIC's assets is conclusive with respect to all claimants, whether or not they received notice, pursuant to R.C. 3903.22(C).
5. Due to the confidential and private nature of the information contained in Exhibit A to the Motion, the Liquidator's *Amended Motion for Order Approving Liquidator's Filing of the Unredacted Corrected Reports of Claims Under Seal* is hereby GRANTED and that unredacted Exhibit A to the Motion shall be filed with the Franklin County Clerk of Court UNDER SEAL.

It is so ORDERED.
