MEMORANDUM IN SUPPORT

On November 6, 2002, the Court ordered Renaissance Health Plan, Inc. ("RHP") into liquidation under Ohio Revised Code Chapter 3903 (the "Liquidation_Order"). The Liquidation Order and O.R.C. § 3903.48 grant the Ohio Superintendent of Insurance, in her capacity as statutory liquidator of RHP (the "Liquidator"), the authority to determine when company records are no longer useful and "...recommend to the court and the court shall direct what records should be retained for future reference and what should be destroyed." O.R.C. § 3903.48.

The Liquidator is preparing to close the RHP estate by year end 2010. Since the inception of the RHP liquidation proceedings, the Liquidator has, among other duties, thoroughly reviewed the books and records of RHP and identified and collected, where reasonable, all known assets of RHP, and has reviewed, valued and classified claims of RHP.

Early in the RHP liquidation process, the Liquidator rented warehouse space near the liquidation office in order to store the RHP documents that were moved to Columbus from RHP's offices following its closing. In 2009, to reduce overhead expenses to the RHP estate, the Liquidator relocated many records that were no longer essential to administering the RHP liquidation estate to Fireproof Records Center for storage until they could be destroyed.

In preparation for the closing of the RHP liquidation estate, the Liquidator is now requesting the Court to authorize the destruction of certain RHP records currently stored at the Fireproof Records Center and at the Liquidator's warehouse that have not been used in the administration of the RHP liquidation estate or will not be useful in the final phase of

the administration of the RHP liquidation estate. (Affidavit of Chief Deputy Liquidator Lynda G. Loomis (“Loomis”), attached hereto as Exhibit 1, ¶ 3 and *see e.g.* O.R.C. § 3903.48). The categories of records to be destroyed are as follows: (1) all pre-liquidation non-essential accounting records; (2) all pre-liquidation administrative and corporate records; and (3) certain records generated during the RHP liquidation proceeding that are not essential to the wrap-up of the RHP liquidation proceeding, including primarily attorney work product in concluded litigation. The schedule identifying the approximately 40 boxes of records to be destroyed is attached hereto as Exhibit A.

The Liquidator has fulfilled her fiduciary duty to policyholders, creditors, and claimants by determining that the documents are no longer of value as they are not required to administer the RHP liquidation estate and the documents can be destroyed. The ongoing expense of retaining such documents should not be the responsibility of the estate in these circumstances. Furthermore, the records must be destroyed at some point anyway and by doing so now, the RHP estate ceases to incur continued storage costs. The destruction expense of approximately \$766.62 can be paid now rather than being reserved for later.

For the reasons stated above, the Liquidator moves this Court for an order pursuant to the Liquidation Order and O.R.C. § 3903.48, which authorizes her to determine when records are no longer useful and to petition the court for an order of destruction. Specifically, the Liquidator seeks an Order that: (1) allows the immediate destruction of the approximately 40 boxes of the RHP records that the Liquidator has selected for destruction because these records are no longer useful to administering the RHP liquidation estate, and (2) authorizes the Liquidator to spend estate assets for such destruction.

1. I am Chief Deputy Liquidator of The Office of the Ohio Insurance Liquidator as appointed by Mary Jo Hudson, Superintendent for the Ohio Department of Insurance.
2. In my capacity as Chief Deputy Liquidator, I supervise those employees of the Liquidator who have custody of and are responsible for maintaining the documents of the Renaissance Health Maintenance Plan, Inc. ("RHP") liquidation estate.
3. As part of the routine administration of liquidation estates, the Liquidator stores records that were placed in storage by the insolvent company prior to liquidation, records that were onsite at the company at the time of liquidation and are subsequently moved to the Liquidator's various storage facilities, and records and documents that were

generated, gathered or received as part of the liquidation process.


4. As the liquidation proceeds, an analysis is done as to whether or not the records are needed and/or useful in the administration of the particular liquidation estate.

5. To the best of my knowledge and belief the records listed on Exhibit A are no longer useful to the administration of the RHP estate.

6. None of the records listed on the Schedule are being used in the claims adjudication process.

7. None of the records recommended for destruction benefit the policyholders, creditors or general public and they are a drain on the assets of RHP.


