ORDER

At the Continuous Hearing on November 21, 2008, this matter came before the Court concerning the November 5, 2008 Liquidator's Turn Over Letter to Christopher M. Likens and Hiram E. Blomquist. Plaintiff, Mary Jo Hudson in her capacity as Liquidator of The Guarantee Title and Trust Company ("Liquidator") appeared by and through her Chief Deputy Liquidator and counsel. Defendant The Guarantee Title and Trust Company ("GTT"), Christopher M. Likens and Hiram E. Blomquist appeared through their counsel. For good cause shown, this Court finds that Christopher M. Likens and Hiram E. Blomquist violated the October 27, 2008 Liquidation Order and prior orders of this Court by failing to turn over all documents that pertain or relate to GTT. It is hereby ORDERED that:

1. Christopher M. Likens (as director, officer and ultimate owner of GTT and Nations Holding Company) and Hiram E. Blomquist (as director and officer of GTT and as employee of Nations Holding Company) turn over to the Liquidator on or before November 28, 2008 all documents that pertain or relate to GTT, regardless of

- ownership, specifically but not limited to, all documents identified in the Liquidator's November 5, 2008 Turn Over Letters to Christopher M. Likens and Hiram E. Blomquist and formally respond to the Liquidator's November 5 Turn Over Letter; and
2. Further violations of this Court's orders may result in monetary sanctions as such violations add unnecessary costs to the administration of estate and to the costs of this case.
