Continuing Education Requirements – Residents Only

29 Resident Surety Bail Bond agents must complete CE requirements.

1. Resident Surety Bail Bond agents must complete 7 CE credits annually before the license may be renewed. The CE credits must be earned with 6 credits specifically approved under the Surety Bail Bond category and 1 credit specifically approved under the Ethics category.
2. The renewal application should not be submitted until after CE credits have been completed.
