RETALIATORY PROVISION (ORC 3901.86A):

When the laws of any other state, district, territory or nation impose any taxes, fines, penalties, license fees, deposits of money, securities or their obligations of prohibitions on insurance companies of this state doing business in such state, district, territory or nation, or upon their agents therein, the same obligations and prohibitions shall be imposed upon insurance companies of such other state, district, or nation doing business in the state and upon their agents.
